Common Recording Errors

You can avoid many year-end problems by careful review of business records now prior to fall visits. Following are a few common "errors" or "omissions".

1. When capital purchases are "dealer financed", those transactions often do not flow through your checking account. Therefore, record the amount borrowed as "**Loan Proceeds**", and as a "**Capital Purchase**". Also, provide copy of purchase agreement to your consultant.
2. Record "Quantities" on all sales and purchases of grain and livestock.
3. Record Coop Patronage Dividend "Equity" received as well as cash paid.
4. Make a list of issues to be reviewed with your consultant when you meet!

Market Outlook Meeting

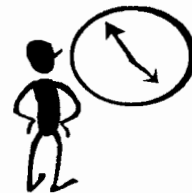

July 13 Marked 63rd Anniversary of MVFBA

■ Since its incorporation in 1940, Mississippi Valley Farm Business Association and its consultants are still serving farmers and their families.

The farm analysis was compiled by hand and then combined into association averages by hand. The factors calculated were basically the same as we use today, however in the 30's the power on farms was horses as well as a few tractors.

The fieldmen (as they were called until the 1960's) covered many more counties than the present day consultants and many of the roads were still dirt paths. Sometimes fieldmen stayed overnight with farm families (to save costs) and few motels/hotels were available.

The Association has witnessed a lot of change in the last 63 years, but still the consultants continue to provide their membership with the services to aid the farmer in his financial decisions.

TAX TIPS



■ Here are some highlights of the recent Tax Law changes to be thinking about before your tax-planning visit.

Section 179 Expense Election:

The new law raised the expense limit to \$100,000 and the total purchases limit to \$400,000. This allows a large amount of variance in scenarios for tax planning this fall.

30% & 50% Bonus Depreciation:

This year you can choose to elect a 50% bonus, a 30% bonus, no bonus or a combination as long as only one is chosen for each life classification. Qualified property must be new property and it must be placed in service after May 6th, 2003 to qualify for the 50% bonus. All new property placed in service

this year qualifies for the 30% bonus.

Capital Gains/Dividends:

The rates of capital gains tax has been reduced to a maximum of 15% for those tax payers who fall in the ordinary tax brackets above 15%. For those who fall in the 10% and 15% ordinary tax brackets, the maximum capital gains rate is only 5%. The rates that dividends are taxed at also have changed. In the past, they have been taxed as ordinary income, but are now subject to the same rates as the new capital gains.

Child Tax Credit:

The Child Tax Credit was raised to \$1,000 per qualifying child. Remember: if you received a check this summer for \$400/child, we can only claim the other \$600 on your return. **Your consultant needs to know what you received at tax planning time!**

With the release of PC Mars 2.0 we now have the ability to post updates on our web site. The release of **PC Mars Plus** this spring. PC Mars Plus will have several **new** abilities.

1. **Inventory Tracking:** This will make it possible to track grain/livestock on hand or any prepaid expenses and automatically include these items on your net worth.
2. **Enterprise Allocation:** This will have the ability to override enterprise allocated for income/expense to give you more complete enterprise reports.
3. **Combine Set of Books:** This ability will allow users to combine two fiscal year books into one calendar year set of books for analysis purposes. (We will also be selling this as a stand-alone utility for PC Mars).
